### **Adoption of the Minutes:**

### ***Active Caseloads PY19***

Mark Farris, Youth Services Manager stated that there are a total of 299 OSY in the program. These total will be divided between In the Door and WGTC.

### ***GED Enrollment PY 19 (OSY)***

Mark stated that In the Door has a total of 55 OSY enrolled and WGTC has a total of 49 OSY enrolled in the GED Program. He stated that there are a total of 104 OSY enrolled in the GED Program.

### **Work Experience PY19 (OSY)**

Mark stated that In the Door have a total of 21 OSY in Work Experience.

### **New Registrations**

Mark stated that In the Door has a total of 2 active registrations and WGTC has a total of 31 new registrations with a total of 33.

### **Exits**

Mark stated that In the Door has a total of 0 Exits and WGTC has a total of 14 Exits.

#### **SCTC Manufacturing Basics Agreement**

Mark asked the Youth Committee for approval for the Manufacturing Basics: SCTC Corporate Training Proposal & Agreement. Mark stated the program will be offered to High Schools Graduates who have been identified by the local school systems in Lamar, Pike and Upson Counties. He stated that the program begins June 2020 – December 2020. Max number of students: 30. Total training hours 80 and cost per participants \$2000, and the maximum agreement amount is \$60,000.
